### A Note from the Assessor:

This review is necessary because of the new AMAR reviews that the State is conducting where they are reviewing parcel record card information. I will be visiting each parcel that has a building to take a new picture of the structure and to measure the structure for the sketch on the record cards. If you have vacant land, there will be no review.

I will not be inspecting the inside of the structure. The property owner does not need to be home at the time of the inspection. I do ask that you please tie up or enclose your dog if it is outside so that no one gets bitten during the inspection. Individual appointments cannot be made, since this work will be done when the weather is cooperating, so any given date and time cannot be guaranteed.
