The initial cart will be free for garbage residents with any additional carts to be paid for by property owner. Supervisor Aho will call a special meeting for Tuesday, October 10, 2023 at 6 pm at the ATCB for public comment. There will be discussion as how to handle the up to 4-month road restrictions enforced by the county road commission on how garbage will be picked up at those times.
