#### **OLD BUSINESS:**

### **Sewer System Project:**

Emmett Bjorn from UP Engineers was present to update the Board on the sewer system upgrade project which is funded through a grant/loan program from the U.S. Department of Rural Development.

Mr. Bjorn was requesting RD Draw request #6 totaling \$3,531.20 for U.P. Engineers invoice dated 4/3/2025.

Motion made by Clerk Patrick, seconded by Trustee Johnson to approve draw request #6. Roll Call Vote: All Ayes; carried.

Mr. Bjorn said that B&B Contracting is complete with all their submittals of the pipes and fittings. Mr. Bjorn also stated that there was a unique, cost saving way with how they are approaching the project by leaving the old structure, putting in one new structure and filling in the older one partially and then pouring concrete to then put in check valves. First payment of the loan was due and with 2 interest payments per year and 1 principal payment.

Mohawk Park Playground Equipment: Equipment will be shipped now that payment has been received.

Mohawk American Legion Building: Nothing to report.

### **NEW BUSINESS:**

**Information from Attorney:** Attorney recommended a course of action, giving them the ability to negotiate the settlement for fiscal year 2023 on the township's behalf.
